4.1 Description of first aid measures

Eve contact

4.3 Indication of any immediate medical attention and special treatment needed

Notes to physician

: To the Doctor: This product contains mineral oil. Accidental injection with this oilbased product, even in small quantities, can cause intense swelling which may, for example, result in ischaemic necrosis and the loss of a digit. Expert PROMPT, surgical attention is required and may necessitate early incision and irrigation of the injected area, especially where there is involvement of finger pulp or tendon.

Specific treatments

: In case of accidental self-injection of oil emulsion vaccines, get medical attention immediately.

SEEK IMMEDIATE MEDICAL TREATMENT at nearest Hospital Emergency Room even if only a very small amount is injected, as failure to treat may result in the mineral oil adjuvant causing sterile abscess and/or loss of affected finger or thumb. 5.3 Advice for firefighters
